Technology, the future of public power, industry trends and developments were a few of the many topics covered this year during presentations, sessions and panel discussions.

Following the Conference Opening Session with AMP President/CEO Marc Gerken, AMP and OMEA welcomed Mark Crisson, president and CEO of the American Public Power Association, with a presentation regarding challenges and opportunities facing the public power industry. During the conference, participants were able to attend panel discussions regarding natural gas trends and municipal financing oversight. AMP 7 Hats Award

Roy Johnson, village administrator for the Village of Carey and AMP Board member, received the prestigious 7 Hats Award during the Awards Banquet on Oct. 30. Johnson was presented the award by AMP President and CEO Marc Gerken for his outstanding accomplishments in utility management and service to his community. Johnson has served Carey for more than 23 years, starting at the wastewater treatment plant and becoming village administrator in 1997. Nominated by Carey Mayor Steven Smalley, Johnson currently oversees more than 30 employees in electric, public works, wastewater, police, tax and administrative departments.

Initiated in 1966 to recognize utility managers who serve smaller communities, the AMP 7 Hats Award is given annually to an administrator in communities of less than 2,500 electric meters. Award winners show skill in seven areas: planning and design, administration, public relations, field supervision, accounting, personnel or employee direction, and community leadership.

Awards were also given to individuals and communities in the categories of environmental stewardship, finance, innovation, public power promotion, safety, and system improvement.

American Municipal Power Wall of Fame

During the Conference, City of Wadsworth, Ohio Electric & Communication General Manager Gene Post was announced at the 2014 inductee to the AMP Wall of Fame.

In 2010, AMP created the American Municipal Power Wall of Fame to pay tribute to those individuals whose commitment, dedication and professionalism have contributed greatly to the success of AMP, our members and public power in general. The actual induction celebration will take place next spring at AMP Headquarters in Columbus.

Post has 40 years of experience in the electric and communication industry with the City of Wadsworth, holding the positions of Apprentice Lineman; Journeyman Lineman; Line Crew Leader; Assistant Superintendent; Superintendent; and General Manager. His dedication and knowledge truly represent the high ideals of public power. But equally important to AMP and our members is Post's work on the AMP mutual aid program. He has served as Gold Sector Mutual Aid Coordinator for 15 years, and as Chairman of the Mutual Aid Committee 10 years. As chairman, Post has worked diligently not only in coordinating response when requests for help have been received, but in making sure that the program runs efficiently, including expanding the program to additional states as AMP membership has grown. He has also been an excellent resource for the American Public Power Association in their efforts to coordinate programs nationally. Post is retiring at the end of the year and he will be missed.
